RESOLUTION NO. 25-20

A RESOLUTION TO AUTHORIZE VARIOUS
THEN AND NOW COMMITMENTS (\$10,606.33 *additional*)

WHEREAS, various Township commitments occurred prior to issuance of a purchase order, as required; and

WHEREAS, the Township Fiscal Officer either has certified or, where applicable, shall certify following approval of this Resolution, that there was at the time of making such commitment (“then”) and at the time of making such certification (“now”) a sufficient sum appropriated for such purpose and in the treasury or in the process of collection to the credit of an appropriate fund free from any previous encumbrances; and

WHEREAS, Section 5705.41(D) of the Ohio Revised Code enables this Board to authorize then and now commitments upon receipt of such certifications; and

WHEREAS, certification by the Township Fiscal Officer of all then and now commitments exceeding \$2,500.00 on behalf of the Township requires prior approval by this Board; and

WHEREAS, certification by the Township Fiscal Officer of all then and now commitments of \$2,500.00 or less on behalf of the Township requires subsequent approval by this Board;

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Township of Twinsburg, County of Summit, State of Ohio:

SECTION 1. Prior Approval. In anticipation of the Township Fiscal Officer’s certification, this Board hereby authorizes all then and now commitments outlined in Exhibit “A” attached hereto. The Township Fiscal Officer is hereby authorized to open then and now purchase orders, in amounts, in favor of vendors, drawn from funds and appropriation line items, and with descriptions and “then” dates, all as outlined in Exhibit “A” attached hereto.

SECTION 2. Subsequent Approval. In recognition of the Township Fiscal Officer’s certification, this Board hereby authorizes all then and now commitments outlined in Exhibit “B” attached hereto. The Township Fiscal Officer has already opened then and now purchase orders, in amounts, in favor of vendors, drawn from funds and appropriation line items, and with descriptions and “then” dates, all as outlined in Exhibit “B” attached hereto.

SECTION 3. Meetings. This Board finds and determines that all formal actions of this Board concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Board and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including but not limited to Section 121.22 of the Revised Code.

SECTION 4. Effective Date. This Resolution shall be effective immediately or at the earliest date allowed by law.

This Resolution is hereby declared to have been adopted by the Board of Trustees of the Township of Twinsburg, County of Summit, State of Ohio, at a meeting, called and held on the 13th day of May, 2020.




