RESOLUTION NO. 39-20

A RESOLUTION TO APPROVE ADDITIONAL APPROPRIATIONS (SUPPLEMENTALS)  
FOR THE FISCAL YEAR, ENDING DECEMBER 31, 2020 (\$9,791.00 *net increase*)

WHEREAS, this Board adopted Resolution No. 19-20 on March 11, 2020, to approve permanent appropriations for the fiscal year, ending December 31, 2020; and

WHEREAS, the Summit County Budget Commission approved a 2020 Amended Official Certificate of Estimated Resources for the Township on August 3, 2020; and

WHEREAS, additional appropriations (supplementals) are necessary at this time, to provide for the current expenses and other expenditures of this Board during said fiscal year;

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Township of Twinsburg, County of Summit, State of Ohio:

SECTION 1. Additional Appropriations (Supplementals). To provide for the current expenses and other expenditures of this Board during the fiscal year, ending December 31, 2020, the following sums be and the same are hereby set aside and appropriated for the several purposes for which expenditures are to be made for and during said fiscal year, noting (1) permanent appropriations as amended through Resolution No. 35-20; (2) change from permanent appropriations amended through Resolution No. 35-20 to additional appropriations (supplementals) approved per this Resolution; (3) additional appropriations (supplementals) approved per this Resolution, and (4) 2020 Certificate Amounts as approved on August 3, 2020 by the Summit County Budget Commission, all as outlined in Exhibit "A" attached hereto.

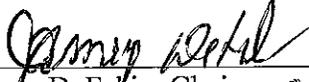

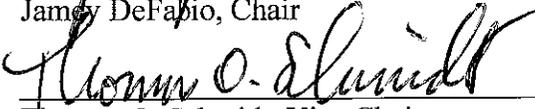
SECTION 3. Effective Date. This Resolution shall be effective immediately or at the earliest date allowed by law.

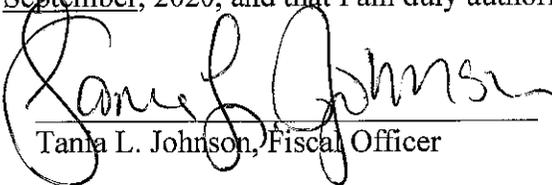
